

1. Enrollment / Eligibility:
 - a. To be eligible for our Foundation Partnership you must:
 - Be at least 18 years old.
 - Have a valid business, website, or social media account where you can promote our products within our delivery region(s).
 - Allow Palouse Ranches to feature your shelter and animals on our social media and website.
 - b. To be eligible for our Homestead Partnership the above must apply, plus you must own or purchase a Palouse Ranches branded shelter and be willing to:
 - Promote your Palouse Ranches shelter on social media platforms, blogs, and/or websites
 - Allow potential customers to tour your shelter if requested. Palouse Ranches **will not** display your address online (unless written permission is given by shelter and property owner(s)) and you will be asked to approve any tour requests in advance. All Homestead tours will be advertised as by appointment only and final details (date, time, address, visiting limitations, etc.) will be arranged directly between Partner and prospective customer.
2. Commission:
 - a. Foundation affiliates will receive a starting commission of **2.50%** on all sales generated through their unique affiliate link. The commission will be paid monthly, on the first of every following month, provided the affiliate has a minimum balance of \$50.00. Commission may also be left as a store credit for future purchases and Palouse Ranches will match credit on file up to 5.00% total combined value.
 - b. Homestead level affiliates will receive a starting commission of up to **5.00%** on all sales generated through their unique affiliate link. The commission will be paid monthly, on the first of every following month, provided the affiliate has a minimum balance of \$50.00. Commission may also be left as a store credit for future purchases.
 - Homestead level partners may also receive discounted shelter pricing should they purchase additional Palouse Ranches shelters.
 - c. Commissions will not be paid for returned or canceled orders.
 - d. Commissions may only be earned on new/initial customer purchases. Existing and returning customer orders will not be eligible for commissions.
3. Promotional materials: Palouse Ranches will provide affiliates with a range of promotional materials, including images, brand guides, banners, and product descriptions, to use on their website or social media accounts. Affiliates are encouraged to create their own unique content as well so long as it fits within the Palouse Ranches mission and brand standards.
4. Promotion guidelines: Affiliates are encouraged to promote our products in a positive and truthful manner, using accurate and up-to-date information. Affiliates are prohibited from

engaging in spamming, unethical or illegal practices, or any other activities that may harm Palouse Ranches' reputation or violate our policies.

5. Termination: Palouse Ranches reserves the right to terminate the affiliate program or any affiliate's participation in the program at any time, for any reason, without prior notice. We also reserve the right to withhold or cancel commissions earned through fraudulent or inappropriate means.
6. Changes to the program: Palouse Ranches reserves the right to modify the affiliate program or these terms and conditions at any time, without prior notice. Affiliates will be notified of any changes via email.
7. Liability: Palouse Ranches will not be liable for any damages, losses, or expenses incurred by affiliates or their customers in connection with the affiliate program or our products.
